THE MAJORITY OF BICYCLES ARE REFURBISHED BY VOLUNTEERS AND GRANTED TO THOSE IN-NEED. THE REMAINDER IS SOLD IN OUR SECOND HAND BIKE SHOP. THE CLIENTS WE SERVE ARE HOMELESS, VETERANS, LOW-WAGE WORKERS, AND LOW-INCOME FAMILIES, HOWEVER, WE HAVE NEVER TURNED ANYONE AWAY FOR FINANCIAL REASONS. AS A COMMUNITY ORGANIZATION WE ARE NOT LIMITED TO BICYCLE REPAID AND HAVE ALSO ASSISTED CLIENT WITH FIXING WHEELCHAIRS, WALKERS, AND CARTS.
